The Science and Engineering Research Board (SERB), established by an act of Parliament, Act 2008, a statutory body, under the Department of Science and Technology, Government of India proposes to fill up the following administrative post on Deputation basis as per the details given below:

(i) <u>UNDER SECRETARY- 01 post</u>

The post of Under Secretary is proposed to be filled on Deputation basis and the following will be the eligibility criteria:

Officers of the Central Government/State Governments or Union territories or Public Sector Undertakings or recognised Research Institutions or Universities or Semi Government or Statutory or Autonomous organisations.

(a) (i) holding analogous posts on a regular basis in the parent cadre department; or

(ii) with five years regular service in the grade rendered after appointment thereto on regular basis in the pay band -3, Rs.15600 - 39,100 with grade pay of Rs.5400 or equivalent; or

(iii) with six years regular service in the grade rendered after appointment thereto on regular basis in the pay band -2, Rs.9300 – 34,800 with grade pay of Rs.4800 or equivalent; or

(iv) with seven years regular service in the grade rendered after appointment thereto on regular basis in the pay band -2, Rs.9300 - 34,800 with grade pay of Rs.4600 or equivalent; or

(v) with ten years regular service in the grade rendered after appointment thereto on regular basis in the pay band -2, Rs.9300 - 34,800 with grade pay of Rs.4200 or equivalent

Note 1: The period of deputation, including the period of deputation in another *ex-cadre* post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed three years.

Note 2: The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application.

Note 3: For the purposes of appointment or deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the recommendations of the Sixth Central Pay Commission has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post (s) for which that grade pay or pay scale is the normal replacement grade without any up-gradation.

GENERAL INSTRUCTIONS

- 1. The number of posts to be filled may vary. The Board reserves the right to cancel the recruitment without assigning any reason.

The suitability of the applicants shall be adjudged by a duly constituted committee, keeping in view, the quality and nature of experience rendered by the candidate and as per the job requirement of the Board, before being called for interview. No correspondence will be entertained from candidates who are not called for interview / selected for appointment. CANVASSING IN ANY FORM WILL RESULT IN DISQUALIFICATION OF CANDIDATURE.

- (b) Candidates working in Government Departments / Public Sector Undertakings / Autonomous Organizations should apply through proper channel along with NOC of the competent authority within the prescribed last date of receiving applications. Such applications will not be considered, if received after the prescribed last date for receiving the applications. However, if an advance copy is submitted by the Applicant to the Board before the last date, the same would be considered in anticipation that the application through proper channel along with NOC would be received by the date of interview.
- (c) Copies of attested certificates in support of educational qualifications, date of birth, etc. should be attached with the application. Candidates will have to produce the original certificates at the time of interview.
