Thus the experience towards same has not been accounted by the Committee. Hence, he is not shortlisted by the Committee.
7.	Devdutt Singh/ 344/Scientist-‘C’ ET	The Screening Cum Shortlisting Committee has made M.Tech degree, as one of the shortlisting criteria. The candidate does not have M.Tech degree awarded, hence he is not shortlisted by the Committee.

Hence, he is not shortlisted by the Committee.

The candidate has claimed an experience of 10.8 years in his application including the experience of 3 years 4 months & 04 months as Project Fellow & SRF respectively towards Ph.D and experience of 11 months & 1 year 1 months towards Post Doc Fellow.
