**OFFICE ORDER**

**Subject: Appointment on compassionate ground in DST for the year 2015.**

Reference:

- (i) DoP&T's OM No. 14014/02/2012-Estt.(D) dated 16<sup>th</sup> January, 2013 and subsequent clarifications issued by DoP&T.
- (ii) DST's O.M. No. A-12012/01/2012-Admn.I(B) dated 21<sup>st</sup> March, 2013.
- (iii) Minutes of the Committee constituted by DST to consider applications for compassionate appointment for the years 2015 & 2016.

A total of 22 applicants were considered for compassionate appointment for the year 2015. The vacancy for compassionate appointment for the year 2015 was 1 (one). On the recommendation of the duly constituted committee for consideration of compassionate appointment cases of DST, DSIR & DBT in accordance with the guidelines of DoP&T, the points obtained by candidates in the compassionate appointment process for the year 2014, as considered by the then Committee, was carried forward & point calculation was done for two additional applicants viz., Sh. Deepak S/o Late Sh. Ram Raj, Daftry, and Sh. Sachin S/o Late Sh. Rajender, MTS who are dependents of government employees of DST & DBT respectively who died in the year 2015, as per the parameters contained in the reference (ii) cited above and information given by the applicants on affidavits submitted by them.

2. The summary sheet of marks obtained by all the eligible candidates considered for compassionate appointment process for the year 2015 has been prepared based on the points obtained as explained in para-1 above and

recommendation for appointment on compassionate grounds for the year 2015 has been done as per this summary sheet of marks obtained.

3. Sh. Laxman Singh, S/o Late Sh. Nannu Singh r/o House No. A-123, 2<sup>nd</sup> Floor, Bapu Park, Kotla Mubarakpur, South Ex Part-1, New Delhi-110003, obtained highest marks viz. 56 out of 100 & was placed at rank 1. Since Sh. Laxman Singh, S/o Late Sh. Nannu Singh does not have the minimum educational qualification required for appointment as MTS, therefore, as of now, he is being appointed as Trainee till he acquires the minimum educational qualification prescribed under RRs for the post of MTS i.e., 10th passed. The period spent in the service as Trainee will not be counted as service for any purpose. Maximum time allowed for a Trainee to acquire minimum educational qualification as per DoP&T's O.M. No. 14014/02/2012-Estt.(D) dated 30.05.2013 is 05 years.

4. The competent authority has considered the recommendations of the Committee and accepted the same.
