### NOTIFICATION

- G.S.R. -In exercise of the powers conferred by the proviso to Article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment of the post of Mission Director, National Mission on Interdisciplinary Cyber- Physical Systems (NM-ICPS) in the Department of Science and Technology under the Ministry of Science and Technology, namely:
- 1. Short title and commencement. (1) These rules may be called the Ministry of Science and Technology, Department of Science and Technology, Mission Director, National Mission on Interdisciplinary Cyber-Physical Systems (NM-ICPS) (Group 'A') Recruitment Rules, 2019.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of posts, classification and level in pay matrix. The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

3.	Method of recruitment, age - limit and qualifications. etc The method of recruitment, age-limit, qualifications and other matters relating to the said
post sh	all be as specified in columns 5 to 13 of the said Schedule.

- 4. Disqualifications. No person, -
- (a) who, has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. There shall be a Search-cum-Selection Committee with the following composition for making recommendation for recruitment or selection to the post of Mission Director, National Mission on Interdisciplinary Cyber-Physical System in the Department of Science and Technology. On recommendation of the Search-cum-Selection Committee, the appointment shall be made by the Appointments Committee of the Cabinet:
- 1. The Secretary, Department of Science & Technology- Chairman;
- 2. One Additional Secretary Level officer from Niti Aayog/ Scientific Department/ Ministry to be nominated by Secretary, Department of Science & Technology Member;
- 3. Two Experts of eminence preferably one each from Academia and Industry to be nominated by Secretary, Department of Science & Technology-Members:

- 6. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving. Nothing in these rules shall affect reservations and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

- (a) Doctorate degree in Natural or Agricultural Sciences or Masters degree in Engineering or Technology or Medicine from a recognised University.
- (b) Fifteen years experience in research and development in industrial and academic institutions or science and technology organisations or scientific activities and services, out of which seven years shall be in administration, planning, development of organization and coordination of science and technology Programme; and
- (c) Experience of evolving, managing and directing science and technology Programme; and
- (d) published research work of high standards.
- (ii) Desirable:
- (a) Post Doctorate research in Natural or Agricultural Sciences or doctorate degree in Engineering or Technology or Medicine from a recognised University or research Institute as evidenced by certification by such University or Institute and publication of research work in journals of repute.

Note: Period spent on acquiring essential qualifications shall not count towards experience. However, period spent on post doctorate research in a University or research Institute as evidenced by certification by such University or Institute and publication of research work in journals of repute, subject to maximum of two years, shall be counted as experience.

The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Government shall ordinarily not exceed Five years. The maximum age limit for appointment by deputation shall be not exceeding 58 years as on the last date of receipt of applications.
