This is in continuation to the lists of eligible and ineligible candidates posted on this Department's website with reference to the above mentioned advertisement.

2. The Screening-cum-Shortlisting Committee constituted by this Department to shortlist the candidates to be called for interview has submitted its report. The lists of candidates shortlisted for interview can be seen at Annexures I to VI.

3. The Committee adopted the following criteria for shortlisting the eligible candidates.

(b). Experience Criteria:

(i) Scientist 'C' posts- Minimum 07 years of experience after acquiring the essential qualification in respective discipline.

(ii) Scientist 'D' posts- Minimum 08 years of experience after acquiring the essential qualification in respective discipline out of which 04 years of experience acquired in science and technology programme, planning, development and co-operation.

2. The interviews are likely to be scheduled in the first/second week of July, 2018. The schedule will be put up on the website after finalization of the same. The candidates will also be informed through email and physical call letters at the addresses given in the application form submitted by them.

3. Candidates need to furnish Equivalence Certificate from Association of Indian Universities (AIU) at the time of interview in case of degree from foreign university.

4. The shortlisted candidates are required to bring their original educational certificates from matriculation onwards and experience certificates complete in all respect upto the date of receipt of applications i.e. till 27.06.2016 in order to confirm the qualification and experience claimed in the applications, failing which they shall not be admitted for interview.
